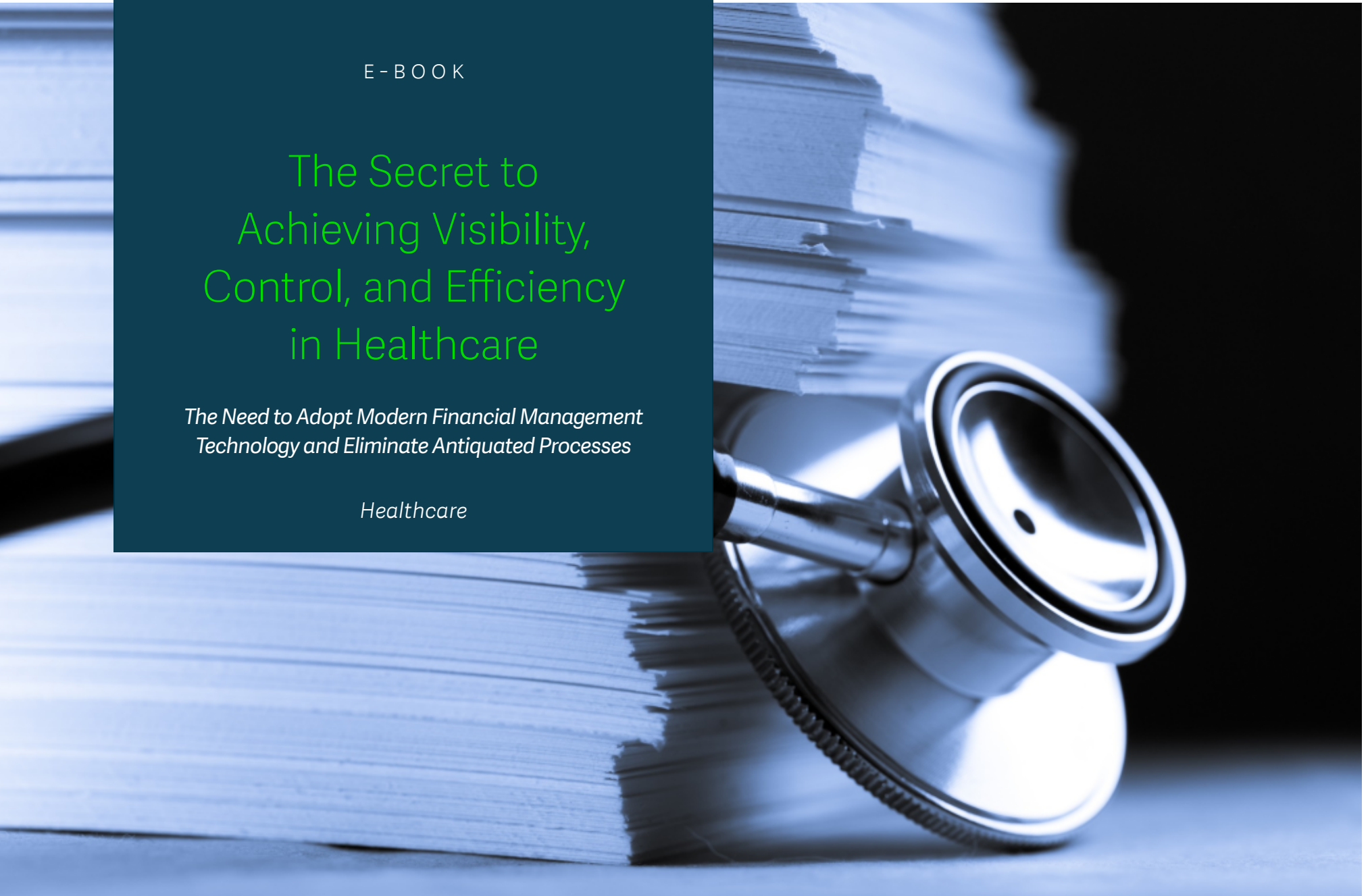

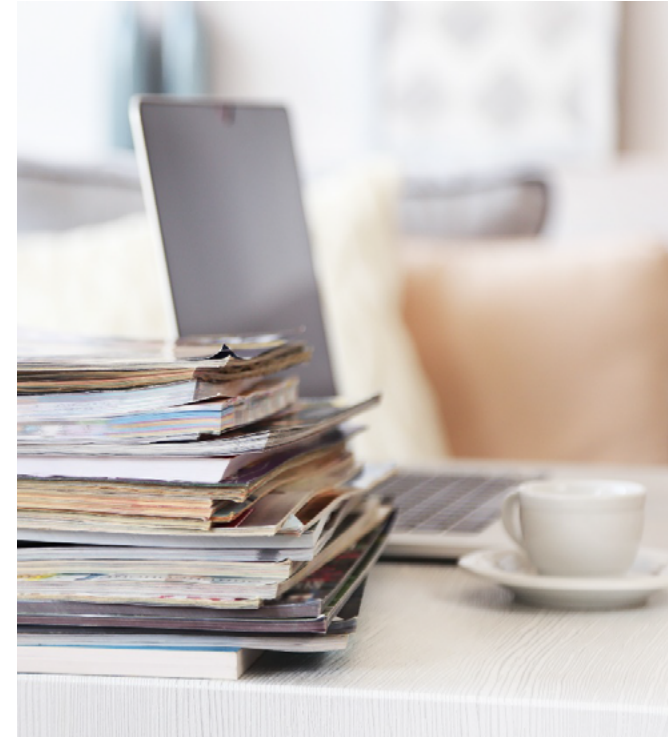
How well has your healthcare organization adapted to the current environment?

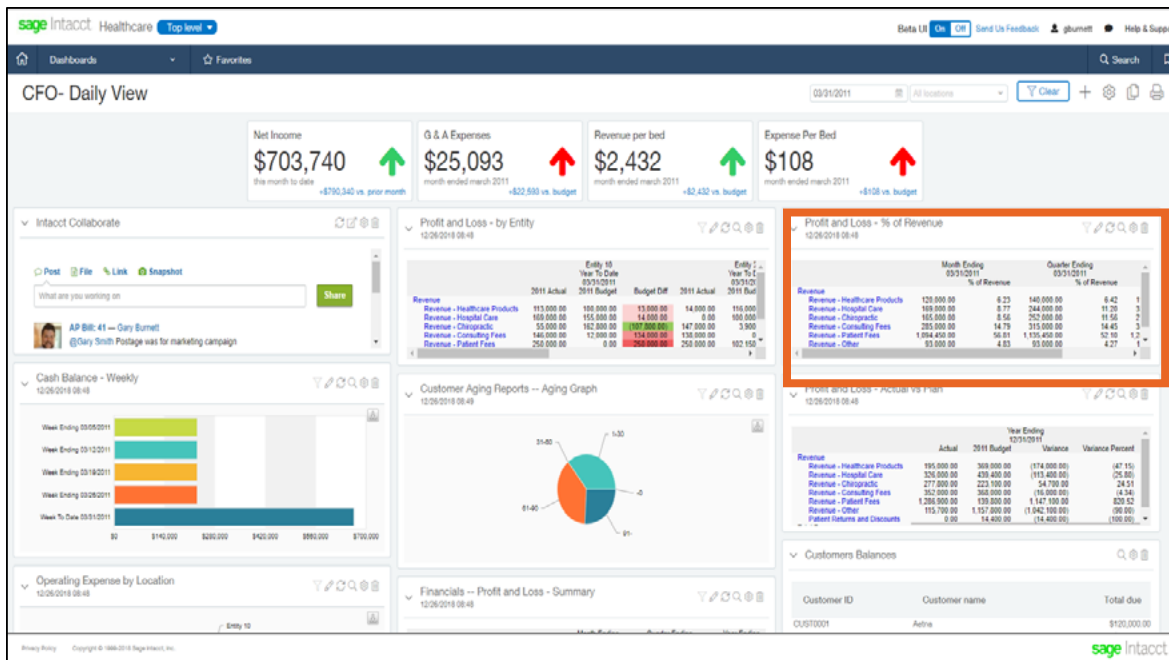

Security and control are especially important in healthcare where organizations must comply with strict regulatory requirements. Be sure you have technology in place to safeguard protected health information—even in your financials.



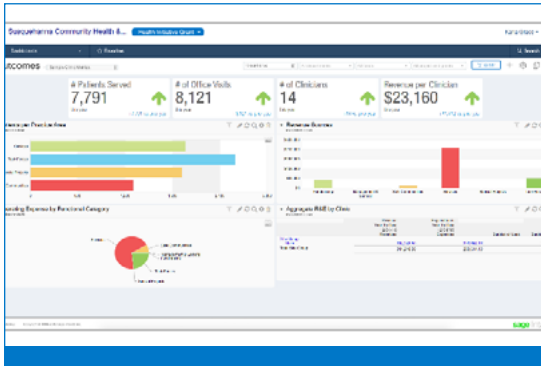
